BE IT ENACTED as the By Law of the Council as follows:

MISSION STATEMENT

“In the spirit of Catholic values, we the students strive to enhance the university experience for all students of King’s University College by providing opportunities for growth and development outside of the classroom and in the King’s, Western and London communities”

PREAMBLE

The King’s University College Students’ Council is the representative body of the student community at King’s University College. The King’s University College Students’ Council derives its duties, responsibilities, and powers from these By-Laws. It is the purpose and duty of the King’s University College Students’ Council to secure and promote the interests and welfare of the student community at King’s University College at the University of Western Ontario, and the principles established by the University of Western Ontario and by King’s University College, and any Act that may be substituted therefore, as from time to time amended. The statements contained herein take precedence over all other King’s University College Students’ Council governing documents.

ARTICLE I: DEFINITIONS

In this By-Law and all other By-Laws and Special Resolutions of the Council, unless the context otherwise requires, the following definitions will be used in the interpretation of the Constitutions:

“**BOD**” means the Board of Directors of King’s University College at the University of Western Ontario.

“**By-Law**” means this By-law and all other By-laws of the Council from time to time in force and effect.

“**Club**” means any organization ratified under the KUCSC Clubs Policy.

“**Coordinator**” means a paid, non-voting member of the KUCSC.

“**Community**” means the students, staff, and faculty of the King’s University College and the University of Western Ontario.

“**Commissioners**” means a non-paid, non-voting member of the KUCSC.

“**Council**” means the KUCSC acting as a representation of the student body of King’s University College.

“**Event Commissioners**” means a non-voting, non paid member who coordinates a specific event on behalf of the KUCSC.

“**Executive**” means collectively or singularly one of the President and/or Vice Presidents of the KUCSC.

“**Ex-Officio**” means a member by virtue of office, who has a voice and whose attendance is not mandatory.

“**KCC**” means the King’s University College Council, of the King’s University College at the University of Western Ontario.

“**King’s Student**” means any person who is registered as a full-time or part-time student at King’s University College, or any person who lives in Residence at King’s University College.

“**KUCSC**” means the King’s University College Students’ Council.

“**KUCSC Board of Directors**” means the President and Vice-Presidents of the King’s University College Students’ Council.

“**Members**” means both voting and non-voting members.

“**Non-Voting Members**” means both coordinators and commissioners.

“**Observer**” means a non-member of the KUCSC who can speak after being yielded to by a member of the KUCSC.

“**Office Manager**” means the employee hired by both the KUCSC and the King’s University College Administration.

“**Plebiscite**” means a vote open to the entire student body of KUC in which the popular vote results in a decision that will show Council the opinion of students, but is not binding.

“Policy” refers to any policy statements or documents or principles as ratified and amended by the KUCSC.

“Referendum” means a vote open to the entire student body of KUC in which the popular vote results in a decision that Council must abide by.

“Regis” means the official KUCSC publication titled as such.

“Representatives” means voting members of the KUCSC but not the Executive.

“Senator” means a student member of U.W.O. Senate.

“Student” means any person who is registered as a full-time or part-time student at the University of Western Ontario or its Affiliate Colleges.

“Turnover” means the meeting where the outgoing Council ratifies the incoming Council.

“USC” means the University Students’ Council at the University of Western Ontario.

“UWO” means the University of Western Ontario.

“Voting Members” means any member who has voting rights on the KUCSC.

ARTICLE II: ADMINISTRATION OF THE COUNCIL

- 1.0** Head Office: Until changed in accordance with these by-laws, the head office of the Council shall be in the City of London, in the County of Middlesex in the Province of Ontario.
- 2.0** Financial Year: The financial year of the Council shall end the last day of April, in each and every year.
- 3.0** Execution of Instruments: The Executive shall appoint three (3) trustees of the Council who may sign deeds, transfers, assignments, contracts, cheques, certificates and other instruments on behalf of Council. In addition, the Executive may from time to time direct the manner in which any particular instrument or class of instrument may be signed.
- 4.0** Banking Arrangements: The banking of Council shall be transacted with such banks, trust companies or other firms or corporations as may from time to time be designated by the Executive

ARTICLE III: TERM OF OFFICE

- 1.0** Each Executive, Representative, Coordinator and Commissioner, having been duly elected or appointed in a manner consistent with these by-laws, shall hold office from the latter of:
 - 1.1** The turnover date of Council stipulated by the outgoing speaker and president which will occur in April in the Council calendar year in which s/he was appointed and elected respectively;
 - 1.2** The day on which s/he was elected or appointed; Until the earlier of:
 - 1.3** At the time of dissolution taking place on the stipulated Council turnover date of the following date of the following Council year; and,

- 1.4 The day upon which his/her term of office shall be terminated by dismissal or resignation by way of consistent with these by-laws and policies.
- 2.0 Notwithstanding section (1), the person elected as the First Year Off-Campus Representative shall hold office during the incoming Council until the following remaining duties have been accomplished:
 - 2.1 Attend budget weekend on behalf of the incoming Off-Campus Caucus to seek funding for the opening budget of the Off-Campus Caucus; and,
 - 2.2 Assist in elections of the First Year Off-Campus Representatives.

ARTICLE IV: AMENDMENTS

- 1.0 The KUCSC may amend these By-laws and Policies from time to time as it is deemed necessary. A motion to amend these By-laws must secure the support of at least two-thirds (2/3) of the voting members at the meeting at which the motion is brought forward.
- 2.0 Any voting member may make a motion to amend these By-laws or Policies.
- 3.0 All motions to amend these By-laws or Policies must be reviewed and recommendations must be made by the appropriate Standing Committee according to the following:
 - 3.1 Before the motion is brought to Council, the Member making the motion shall submit the proposed amendments to the Speaker and Deputy Speaker
 - 3.2 The Speaker will then defer it to the appropriate Standing Committee; and,
 - 3.3 If the motion is brought to Council either as a posted motion or as new business without having been reviewed by a Standing Committee, the Speaker shall refer it to the Committee except as otherwise provided herein;
 - 3.3.1 Any proposed amendments submitted to the Committee after the summer meeting and before the first.
- 4.0 Standing Committees shall review all proposed amendments and as deemed necessary make recommendations to the mover on the following:
 - 4.1 The wording or grammar of the proposed amendments;
 - 4.2 Modifications to other sections of these By-laws or Policies which will be affected by the proposed amendments; and,
 - 4.3 Any comments or concerns about the merits or ramifications of the proposed amendments.
- 5.0 Nothing in subsection 4.0 is to be taken to mean that the Standing Committees have the power to confirm, reject, amend, or otherwise deal with a proposed change to these By-laws or Policies. The Standing Committees shall recommend modifications to the proposed change to the By-laws or Policies for the sole purpose of giving effect to the proposed change and not to defeat the proposed change. However, in the event that the Standing Committees views the proposed change to be contrary to best interests of the Council, the Standing Committees shall inform Council of this.
- 6.0 All By-law or Policy amendments must be posted four (4) days in advance of the meeting where it is to be considered;
 - 6.1 By-law or Policy amendments may be brought forward during “New Business” at the discretion of the Speaker.

Article V: STRUCTURE

- 1.0** The KUCSC consists of several main groupings: the Executive, The Representatives, The Commissioners and the Coordinators.
- 2.0** The Executive shall consist of:
 - 2.1** The President;
 - 2.2** The Vice-President Events;
 - 2.3** The Vice President Finance;
 - 2.4** The Vice President Student Issues; and,
 - 2.5** The VP Communications.
- 3.0** The Representatives shall consist of:
 - 3.1** Five (5) Representatives – University Students’ Council;
 - 3.2** Two (2) Representative – University Students’ Council First Year Residence;
 - 3.2.1** The KUCRC President may hold one of these positions if when the KUCSC President makes an offer of a vote, they accept. If the voting position is accepted then the KUCRC President will be granted a voting position on the KUCSC and will be held liable to all aspects of the KUCSC attendance policy.
 - 3.3** Three (3) Representatives – King’s College Council;
 - 3.4** One (1) Representative – Saint Peter’s Seminary;
 - 3.5** Two (2) Representative – First Year Off Campus Students;
 - 3.6** One (1) Representative – Social Work;
 - 3.7** One (1) Representative – Mature Students;
 - 3.8** One (1) Representative – Graduating Class Representative;
 - 3.9** Two (2) Representatives – Modern Language Faculties; (1 enrolled in Honours French, 1 enrolled in Honours English)
 - 3.10** Two (2) Representatives – Business, Math, Economics Faculties; (1 enrolled in Honours Economics program, 1 enrolled in Honours MOS program)
 - 3.11** One (1) Representative – History Faculty;
 - 3.12** One (1) Representative – Philosophy Faculty;
 - 3.13** One (1) Representative – Political Science Faculty;
 - 3.14** One (1) Representative – Psychology Faculty;
 - 3.15** One (1) Representative – Religious Studies Faculty;
 - 3.16** One (1) Representative – Sociology Faculty;
 - 3.17** One (1) Representative – Childhood and Social Institutions Faculty; and,
 - 3.18** One (1) Representative – Social Justice and Peace Faculty; and,
 - 3.19** Two (2) Representatives – Affiliate Colleges Senators,
 - 3.20** One (1) Representatives – Exceptionalities,
 - 3.21** One (1) Representatives – International Students
- 4.0** The Commissioners shall consist of:
 - 4.1** The Advertising Commissioner(s);
 - 4.2** The Athletics Commissioner(s);
 - 4.3** The Charity Commissioner(s);
 - 4.4** The Clubs Commissioner(s);
 - 4.5** The Clubs Finance Commissioner;
 - 4.6** The Dry Events Commissioner(s);
 - 4.7** The Environmental Commissioner(s);

- 4.8 The Fashion Show Commissioner(s);
 - 4.9 The Games Room Commissioner(s);
 - 4.10 The King's Ball Commissioner(s);
 - 4.11 The King's Wheels Commissioner(s)
 - 4.12 The Media Commissioner(s)
 - 4.13 The Off-Campus Commissioner(s);
 - 4.14 The Orientation Commissioner(s);
 - 4.15 The Promo-Team Commissioner(s);
 - 4.16 The Regis Commissioner(s);
 - 4.17 The Special Events Commissioner(s);
 - 4.18 The Concert Commissioner(s); and,
 - 4.19 The Student Outreach Commissioner(s)

 - 4.22 The Website Commissioner(s);
- 5.0 The Coordinators shall consist of;
- 5.1 The Athletics Facilities Coordinator(s);
 - 5.2 The King's Connection Coordinator(s);
 - 5.3 The Event Staff Coordinator(s); and,

ARTICLE VI: QUALIFICATIONS

- 1.0 Membership of the KUCSC is open to any student subject to election or appointment as outlined in these By-laws.
- 2.0 Any voting member who ceases to be a Student of King's University College also ceases to be a voting member of the KUCSC;
 - 2.1 If the student in question has been a King's University College student for at least one year, this can be overruled by an affirmative vote of Council.
- 3.0 Any member who ceases to be a student at the University of Western Ontario will cease to be a member.
- 4.0 No KUCSC member may seek or hold another position that shares the same term of office on the KUCSC.

ARTICLE VII: DUTIES, EXECUTIVE MEMBERS

- 1.0 The Executive will:
 - 1.1 Perform his/her duties as specified in these By-laws;
 - 1.2 Be a member of the King's College Council;
 - 1.3 Attend meetings as specified by this Constitution;
 - 1.4 As a single body, act upon its own authority in the months of May, June, July and August if Council cannot meet, provided that the action is of an urgent and pressing nature, and further provided that the action is reported to Council as soon as possible;
 - 1.5 Call meetings with their portfolio as a whole during the academic year as needed;
 - 1.6 Be responsible to prepare a budget for their position and oversee the preparation of their portfolio budgets;

- 1.7 Be responsible to prepare a report to Council which will be due each meeting and will be subject to the approval of Honorarium Committee in order to receive a monthly honorarium;
 - 1.7.1 The total annual honoraria per Executive member will be calculated as at a full-time student's tuition and fees;
 - 1.7.2 The President will receive an additional 5% bonus;
 - 1.8 Take a maximum of three and a half (3.5) courses during the term in office;
 - 1.9 Consist of members who have achieved a minimum of a sixty-five percent (65%) grade average either cumulatively or in the last academic year;
 - 1.9.1 An appeal process will be conducted if necessary by the Administrative Student Council Advisor;
 - 1.10 Not be comprised of any member who is enrolled in the Richard Ivey School of Business;
 - 1.11 Not be comprised of any members who are no less than 18 years of age;
 - 1.12 Not be comprised of any members who have been found to be of unsound mind by a court in Canada or elsewhere;
 - 1.13 Not be comprised of any members who have a status of a bankrupt;
 - 1.14 Have a voice and vote at KUCSC meetings;
 - 1.14.1 Only the Presidents and Vice-Presidents will have a vote at meetings of the BOD;
 - 1.15 The Executive may add duties to any other officer and may vary or limit such additional duties;
 - 1.16 The Executive shall have the power to appoint agents or attorneys for the Council with such powers of management or otherwise (including the power to sub-delegate) as may be thought fit; and,
 - 1.17 The duties of all other members of the Council shall be such as the terms of their engagement call for or as the Executive may prescribe. Any of the powers and duties of an officer to whom an assistant has been appointed may be exercised and performed by such assistant, unless the Executive otherwise directs.
- 2.0 The President:
- 2.1 Chair the KUCSC Executive;
 - 2.2 Be the official voice of the KUCSC;
 - 2.3 Be a voting member of the BOD;
 - 2.4 Be a voting member of the King's College Faculty Council;
 - 2.5 Be a voting member of the University Students' Council;
 - 2.6 Be a member of the Educational Policy Committee;
 - 2.7 Be an ex-officio member of all KUCSC Committees;
 - 2.7.1 With the exception of the Honorarium Committee
 - 2.8 Be a liaison with the Vice Presidents of Council;
 - 2.9 Be a liaison with the Principal;
 - 2.10 Act as a liaison with the Administration of the King's University College;
 - 2.11 Be responsible for the duties of the:
 - 2.11.1 Speaker;
 - 2.11.2 KCC Representatives;
 - 2.11.3 USC Representatives;
 - 2.11.4 First Year Residence Representative; and,
 - 2.11.5 King's University College Residence Council President; and,
 - 2.12 Be responsible for the Office Manager;
 - 2.13 Be responsible for holding Executive meetings;
 - 2.14 Sign all minutes and legal documents pertaining to the KUCSC;
 - 2.15 Have the authority to co-sign all cheques written by the KUCSC;

- 2.16 Have signing authority on the KUCSC's USC Account;
- 2.17 Be responsible for coordinating mid-year and year-end reports;
- 2.18 Train and serve as an assistant to the president-elect for two weeks prior to KUCSC turnover and for two weeks post-presidential turnover;
- 2.19 Coordinate the efforts and activities of the student members of the King's College Council;
- 2.20 Coordinate the efforts and activities of the student members of the King's College Faculty Council;
- 2.21 Sit on executive committee and Nominating Subcommittee of College Council and the Board of Directors;
- 2.22 Be a member of the Planning, Campus Development, and Property Planning Committees of King's University College; and,
- 2.23 Sit as President for a maximum of two terms.

3.0 Vice-President Events:

- 3.1 Be responsible for coordinating student events;
- 3.2 Be responsible for coordinating, with the VP Finance, tickets sales for Council organized events;
- 3.3 Be a member of the Events Standing Committee (ex-officio);
- 3.4 Be responsible for the activities of the:
 - 3.4.1 King's Ball Commissioner(s);
 - 3.4.2 Special Events Commissioner(s);
 - 3.4.3 Orientation Event Commissioner(s);
 - 3.4.4 Athletics Commissioner(s);
 - 3.4.5 Event Staff Coordinator(s);
 - 3.4.6 Dry Events Commissioner(s);
 - 3.4.7 Fashion Show Commissioner(s);
 - 3.4.8 Charity Commissioner(s);
 - 3.4.9 Concert Commissioner(s);

- 4.4 Have authority to co-sign all cheques written by the KUCSC;
- 4.5 Have signing authority on the KUCSC's USC Account;
- 4.6 Be responsible for the activities of the:
 - 4.6.1 Treasurer
 - 4.6.2 Pro Shop Coordinator(s)
 - 4.6.3 Athletics Facilities Coordinator(s)
 - 4.6.4 Games Room Commissioner
 - 4.6.5 Clubs Finance Commissioner
 - 4.6.6 King's Wheels Commissioner
- 4.7 Be responsible for the duties of all members of the finance portfolio in their absence;
- 4.8 Be responsible for the financial management of the Pro-Shop;

- 4.9 Be responsible for overseeing the financial obligations for all Clubs ratified by the KUCSC;
 - 4.10 Be responsible for the collection and review of all budget materials;
 - 4.11 Approve all cheque requisition;
 - 4.12 Be a member of the Finance Standing Committee (ex-officio);
 - 4.13 Chair the Budget Review Sub Committee;
 - 4.14 Sit on the budget and planning committee of College Council as well as the Board of Directors;
- 5.0 Vice President Student Issues:**
- 5.1 Be responsible for recognizing and receiving concerns of the student body;
 - 5.2 Be responsible for the administration of activities of all Clubs and their respective Executive members;
 - 5.3 Be responsible for the activities of the:
 - 5.3.1 Environmental Commissioner(s);
 - 5.3.2 Clubs Commissioner(s);

 - 5.4 Coordinate the efforts and activities of the:

- 6.0 Vice President Communications:**
- 6.1 Be an internally elected Vice President of the KUCSC.
 - 6.2 Be responsible for implementing an effective communications program for the KUCSC and for advising members on their communications associated with their positions on the KUCSC;
 - 6.3 Be responsible for advising the Council and the KUCSC Board of Directors on media relations;
 - 6.4 Be responsible for, in conjunction with the President, establishing and working to improve relationships and partnerships within the King's and Western Community
 - 6.5 Be responsible for informing the media outlets of King's, Western and London of events, initiatives, and successes related to the KUCSC, and the student body;
 - 6.6 Act as the Chief Returning Officer (CRO) during times of King's elections and act as Chair of the Elections Sub Committee;
 - 6.7 Be a member of the Communications Committee (ex-officio);
 - 6.8 Release press statements, in conjunction with the President, regarding any pertinent information that impacts the status of the KUCSC and King's Students;
 - 6.9 Be responsible for the activities of the:
 - 6.9.1 Media Commissioner(s);
 - 6.9.2 Regis Editor(s);

- 6.9.3 Website Commissioner(s);
 - 6.9.4 Advertising Commissioner(s);
 - 6.9.5 Promo Team Commissioner (S);
 - 6.10 Chair the Regis Advisory Board and have the official ability with the Board's authority to appoint or temporarily appoint Editor and Assistant Editor in the absence of Editor to carry out duties over a period of one month;
 - 6.11 Be ineligible to run for any elected KUCSC position during their term;
 - 6.12 Act as liaison among the KUCSC, the Office of the Registrar, Student Financial Services, Campus Ministry and the Office of the Academic Dean to support the KUCSC's goal of ensuring effective dissemination of information to all students of King';
 - 6.13 Keep abreast of municipal, provincial and federal issues, focusing on student related news, and advise the Council on the effects of such development;
 - 6.14 Be aware of and report to the Executive and Council, on the activities of the London City Council.
- 7.0 The duties of all other members of the Council shall be such as the terms of their engagement call for or as the Executive may prescribe. Any of the powers and duties of an officer to whom an assistant has been appointed may be exercised and performed by such assistant, unless the Executive otherwise directs.

ARTICLE VIII: DUTIES, OFFICE MANAGER:

- 1.0 Serve as recording secretary and office manager.
- 2.0 Liaise between Council and the King's University College Technology Services Department;
- 3.0 Maintain all official records and files for KUCSC.
- 4.0 Be responsible for the administrative matters relating to the King's University College's Administration, including the booking of rooms and events;
- 5.0 Be responsible for maintaining financial records, regular reporting of financial position of KUCSC and handle financial matters particular to the orientation program and King's Connection.
- 6.0 Develop, institute and administrate an asset control program for all KUCSC property, resources, and information;
- 7.0 Assist the Vice President Finance with the budgeting and reviewing of the monthly Activity Fee account.
- 8.0 Maintain information technology, and information, and office equipment.
- 9.0 Record, distribute, and file minutes of all KUCSC meetings (general meetings, executive committee meetings, committee and sub-committee meetings and emergency meetings as necessary).
- 10.0 Ensure all documents (including constitution, amendments, policy manuals, position manuals) and reports are updated and filed.
- 11.0 Maintain files of all legal and insurance documentation.
- 12.0 Ensure copies of documents and reports are filed with Dean of Students.
- 13.0 In conjunction with the Vice President Finance:
 - 13.1 Responsible for maintenance of KUCSC financial records
 - 13.2 Preparation of all cheques for authorization and distribution of same;
 - 13.3 Responsible for financial matters pertaining to the Orientation Program and management of financial activities throughout Orientation (including Soph Weekend);
 - 13.4 Responsible (with The King's Connection Commissioners) for all finances relating to the King's Connection daily sales records.

ARTICLE IX: DUTIES, REPRESENTATIVES

- 1.0** Each representative will:
- 1.1** Attend meetings as specified in this By-law;
 - 1.2** Represent and advocate on behalf of the students;
 - 1.3** Seek areas in which his/her portfolio can be expanded, and take appropriate action to improve his/her effectiveness as a Representative;
 - 1.4** Prepare a budget pertaining to his/her portfolio at the request of the Vice President Finance;
 - 1.5** Have a vote and voice at KUCSC meetings;
 - 1.6** Be responsible for joining at least one KUCSC Standing Committee; and,
 - 1.7** Be responsible for meeting with the incoming Representative at least once before and after Turnover.
- 2.0** KCC Representatives:
- 2.1** Be responsible to the President;
 - 2.2** Be a voting member of the King's College Council as well as the KUCSC and be the voice of Kings' Students;
 - 2.3** Perform his/her duties as specified by the KCC;
 - 2.4** Act as a liaison between the KUCSC and the KCC and the King's Students and the KCC; and,
 - 2.5** Be a liaison for the King's United Way Campaign for the Council.
- 3.0** Faculty Representatives:
- 3.1** Be responsible to the Vice President Student Issues;
 - 3.2** Be a voting member of the King's University College Faculty Council;
 - 3.3** Consist of one or more (at the discretion of the faculty) representatives from each and every faculty of King's University College;
 - 3.4** Be responsible for attending Faculty Council meetings;
 - 3.5** Be responsible for attending Faculty department meetings;
 - 3.6** Be responsible for assisting students in their faculty with questions, concerns, or complaints about the faculty, assist students in seeking proper channels regarding academic assistance;
 - 3.7** Coordinate faculty events with their respective faculty and/or club;
 - 3.8** Must be a third or fourth year student at King's; and,
 - 3.9** Must be enrolled in an Honours program that corresponds to their position on the KUCSC.
- 4.0** First Year Off Campus Students' Representatives:



 - 1.6 Establish, as necessary assistants or committees to aid in the performance of his/her duties, but these assistants or committees will not be exclusive to members of Council or committees of Council, respectively, and hence all responsibility for the Coordinators' portfolio will lie with the Coordinators and not with any assistants or committees.
- 2.0** The Event Staff Coordinator:

 - 6.1.1** If written notice of a meeting is provided to all committee members at least four (4) days in advance then quorum shall be constituted as one-third (1/3).
 - 6.2** Be calculated based on the number of Members appointed to the Committee at any given time.
- 7.0** The Finance Committee shall:
- 7.1** Meet no less than once per month during the Academic year;
 - 7.2** Be responsible for:
 - 7.2.1** Reviewing and making recommendations to council on student fee amounts collected by the KUCSC;
 - 7.2.2** Reviewing and approving all unbudgeted expenses up to five hundred (500) dollars;
 - 7.2.2.1** Will make a recommendation to Council for all expenses deemed worthy of pursuit that total more than five hundred (500) dollars
 - 7.2.2.2** It is at the discretion of the Finance Committee to decline proposals
 - 7.2.3** Reviewing and making recommendations to Council on all matters that relate to the finances of the KUCSC;
 - 7.2.4** Reviewing the activities of all KUCSC positions in the Finance portfolio;

- 8.0** The Communications Committee shall;
- 8.1** Meet no less than once per month during the Academic year;
- 8.2** Be responsible for:
- 8.2.1** Making policy and procedure recommendations to Council on the following:
- 8.2.1.1** Effective communication and promotion of KUCSC activities and initiatives;
- 8.2.1.2** Media relations;
- 8.2.1.3** Volunteer recruitment and recognition.
- 8.2.2** Reviewing and making recommendations to Council on all matters that relate to the Communications portfolio;
- 8.2.3** Reviewing the activities of all KUCSC positions in the Communications portfolio;
- 9.0** The Student Issues Committee shall:
- 9.1** Meet no less than once per month during the Academic year;
- 9.2** Be responsible for:
- 9.2.1** Developing an awareness among the student body of social and cultural issues;
- 9.2.2** Advocate on behalf of King’s Students for matters pertaining but not limited to: academics, accessibility, cultural, and social issues;
- 9.2.3** Conducting the Student Awards process:
- 9.2.3.1** The committee will be responsible for receiving nominations for the KUCSC Golden “K” Award, the KUCSC Service Award, the KUCSC TA Award for Excellence, the KUCSC International Student Award as
- 9.2.3.2** Will be responsible for facilitating the selection process of said awards.
- 9.2.4** All club related matters as outlined in the KUCSC Clubs Policy;
- 9.2.5** Reviewing and making recommendations to Council on all matters that relate to the Student Issues portfolio;
- 9.2.6** Reviewing the activities of all KUCSC positions in the Student Issues portfolio;
- 10.0** The Events Committee shall:
- 10.1** Meet no less than once per month during the Academic year;
- 10.2** Be responsible for:
- 10.2.1** Making policy and procedure recommendations to Council on the following:
- 10.2.1.1** Implementation of programs, services, and opportunities that engage students;
- 10.2.1.2** Risk management of KUCSC events;
- 10.2.1.3** Orientation Week;
- 10.2.1.4** Sponsorship for charitable events;
- 10.2.2** Reviewing past events and reporting on what improvements can be made;
- 10.2.3** Reviewing the logistics of upcoming major events to ensure safety, accessibility, and efficiency;
- 10.2.4** Reviewing and making recommendations to Council on all matters that relate to the Events portfolio;
- 10.2.5** Reviewing the activities of all KUCSC positions in the Events portfolio;
- 11.0** The Elections Committee shall:
- 11.1** Be an Ad-Hoc Committee of the Communications Committee;
- 11.2** Consist of:
- 11.2.1** The VP Communications as Chair;

- 13.3.3 Bringing feedback to the attention of the corresponding member of Council prior to the next Committee meeting.
- 13.3.4 Be responsible for:
- 13.3.5 Deciding if there is due cause in withholding some or all of an individual's honoraria;
- 13.3.6 Giving a presentation to Council when honoraria has been withheld;
- 13.3.7 Meeting no less than three (3) times per academic year:
 - 13.3.7.1 The meetings must take place at the end of each semester as well as after the summer period;
 - 13.3.7.2 Any additional meetings can be at the discretion of the Chair.

ARTICLE XIV: MEETINGS

- 1.0 The Executive will meet at the discretion of the President, but not less than bi-weekly:
 - 1.1 The President will chair the Executive Meetings.
- 2.0 The President, upon advice from Council and the Speaker will establish a schedule for KUCSC General meetings;
 - 2.1 The President may call other meetings at his/her discretion;
 - 2.2 The Speaker will preside at all meetings, if the Speaker is unable to attend based on extenuating circumstances, the Deputy Speaker will act his/her stead;
 - 2.2.1 If both the Speaker and Deputy Speaker are unable to attend, the President shall conduct the election of a member to serve as Speaker for that meeting;
 - 2.3 The Office Manager will record the minutes as outlined in these;
 - 2.4 Attendance is mandatory for all meetings for all members in accordance with the Attendance Policy;
 - 2.5 All meetings are open to the community, and will include a section title "Presentations to Council" at the start of each, with the exception of Turnover meetings and the meetings held in the Seminary;
 - 2.6 Notwithstanding subsection 2.6, any voting member may make a Privileged Motion to hold a meeting, or a part thereof, in camera; and,
 - 2.7 The following shall be held as the order of precedence for conducting meetings and operations of the KUCSC: The By-laws, KUCSC Policies, Robert's Rules of Order;
 - 2.7.1 The parliamentary authority of all meetings will be Robert's Rules of Order. If, in any case, this is contrary to Robert's Rules of Order, this By-law or policies will govern.
- 3.0 Each Standing Committee will meet at least once prior to all Council meetings during the Academic year;
 - 3.1 Additional meetings will be held at the discretion of the Chair.
 - 3.2 If a Standing Committee is not able to meet the week before council, the Chair must communicate with the committee members via email or other means.
- 4.0 No member shall be entitled to vote by proxy at any time.

ARTICLE XV: FUNDS

- 1.0 The KUCSC shall derived its revenues from:
 - 1.1 Any "activity fee" determined by the KUCSC and collected from each student;

- 1.2 Any grants or subsidies received from the USC and/or King's University College Administration; and,
- 1.3 Any other sources, as set from time to time, by the KUCSC.

ARTICLE XVI: DISMISSALS

- 1.0 A motion to dismiss any member of the KUCSC must secure the support of at least two thirds (2/3) of the voting members present at a general meeting of which there has been notice of the intention to pass the resolution.
- 2.0 A motion to dismiss a member may occur when any other of the following conditions occur;
 - 2.1 A member fails to perform his/her duties and responsibilities as outlined in the KUCSC by-law.
- 3.0 The dismissal of a member will occur when any of the following conditions occur;
 - 3.1 A member is in violation of the Attendance Policy.

ARTICLE XVII: ELECTIONS

- 1.0 The VP Communications will oversee the running of elections in the capacity of Chief Returning Officer (C.R.O).
- 2.0 The VP Communications will organize an Elections Committee to perform its duties as outlined in the Elections Policy.
- 3.0 To win an election, a candidate must secure a majority of votes.
- 4.0 No KUCSC Executive Member can endorse any candidate in KUCSC elections.
- 5.0 The KUCSC will hold elections for:
 - 5.1 The President;
 - 5.2 The Vice President Events;
 - 5.3 The Vice President Student Issues;
 - 5.4 The Faculty Representatives;
 - 5.5 The First Year Off-Campus Students' Representative;
 - 5.6 The Graduating Class President;
 - 5.7 The Graduating Class Valedictorian;
 - 5.8 The Mature Students' Representative;
 - 5.9 The International Students' Representative;
 - 5.10 At the request of the USC, the KUCSC will hold elections for the USC Representatives, the First Year Students' Caucus Representative and the USC Residence Representative;
 - 5.11 At the request of the KCC, the KUCSC will hold elections for the KCC Representatives;
 - 5.12 St. Peter's Seminary will determine who will serve as the St. Peter's Seminary Representative; and,
 - 5.13 The School of Social Work Association will determine who will serve as the Social Work Representative.
- 6.0 All students are eligible to vote in elections;

- 6.1** Notwithstanding section 5.0, only first year off campus students may vote to elect the First Year Off Campus Students' Representative;
- 6.2** Notwithstanding section 5.0, only students living in residence may vote to elect the First Year Residence Representative;
- 6.3** Notwithstanding section 5.0, only students of the Graduating Class may vote to elect the Graduating Class President;
- 6.4** Notwithstanding section 5.0, Vice Presidents will be elected by the voting members identified in the KUCSC Vice Presidents Elections Policy.
- 7.0** The nomination period of the President will be open no earlier than January twentieth (20), and will last at least one (1) week:
- 7.1** The campaign period will follow the nomination period and last one (1) week;
- 7.1.1** The Campaign period will include an All Candidates' Forum, which will be set by the C.R.O.;
- 7.2** The election will be held on the two (2) consecutive days following the close of the campaign period.
- 8.0** Nominations for the positions of First Year Off Campus Representative, the First Year Students Caucus Representative and First Year Residence Representative will open no earlier than September fifteenth (15) and last at least one (1) week;
- 8.1** The campaign period will follow the nomination period, last one week.
- 8.2** The election will be held on two (2) consecutive days following the close of the campaign period;
- 8.3** In any case the election must be completed by the fourth Friday in November.
- 9.0** Nominations and elections for USC Representatives, Faculty Representatives, Exceptionalities Representative, Mature Students' Representative, and International Students' Representative will coincide with that of the President.
- 10.0** Nominations for Vice Presidents will open the Monday of the week of Presidential election results and will close the following Monday;
- 9.1** Elections for internally-elected Vice Presidents will take place at the KUCSC Annual General Meeting (AGM) and adhere to the KUCSC Vice President Elections Policy;
- 9.1.1** Only the Vice President position of VP Finance shall be elected internally by the KUCSC;
- 9.1.2** The election period will include an all Candidates forum as set by the C.R.O.;
- 9.1.3** The AGM will include a separate debate for each individual internally-elected Vice Presidential office.
- 9.1.4** Only the Vice President positions of VP Student Issues and VP Events shall be elected externally by the King's Student Body.
- 9.1.5** The Campaign period for the externally-elected Vice Presidents will include an All Candidates' Forum, on a separate date to the Presidential All Candidates' Forum, which will be set by the C.R.O.;
- 9.1.6** The elections period for the externally elected Vice Presidents will take place at a time determined by the C.R.O.
- 10.1** Nominations for the Graduating Class President will open no later than seven (7) days following the KUCSC Annual General Meeting;
- 10.2** The campaign period will follow the nomination period, lasting one week;
- 10.3** The election will be held on two (2) consecutive days following the close of the campaign period;

- 10.4** In any case, the election must be completed prior to the KUCSC Turnover meeting.
- 11.0** In the event of a tie:
- 11.1** With 3 or more nominees on one ballot, the election will be re-opened between the tied candidates, allowing 24 hours to campaign, followed by the ballot opened for 24 hours;
- 11.2** If the candidates are still tied, then the winner will be chosen by lot;
- 11.3** On a ballot with only 2 nominees, it shall be decided by a coin toss initiated by the C.R.O.
- 12.0** In the case where an Executive position only has one nominee, they must secure a vote of confidence from the student population;
- 12.1** A presidential nominee will have 24 hours after the nomination is closed to campaign, followed by the vote opening for 24 hours where the nominee must secure a majority vote;
- 12.2** In the event that there is only one Vice Presidential candidate for a specific office, the candidate will be elected by a vote of confidence by council at the KUCSC Annual General Meeting.

ARTICLE XVIII: APPOINTMENTS

- 1.0** The Executive, as a whole, will be responsible for appointing all positions except the Orientation Week Commissioner.
- 2.0** The following positions will be appointed:
- 2.1** The VP Communications
- 2.2** The Speaker
- 2.3** The Athletics Commissioner(s)
- 2.4** The Advertising) Commissioner(s)
- 2.5** The Clubs Commissioner
- 2.6** The Clubs Finance Commissioner
- 2.7** The Communications Commissioner(s)
- 2.8** The Dry Events Commissioner(s)
- 2.9** The Environmental Commissioner(s)
- 2.10** The Event Staff Coordinator
- 2.11** The Fashion Show Commissioner(s)
- 2.12** The Games Room Commissioner(s)
- 2.13** The Special Events Commissioner(s)
- 2.14** The International Students' Commissioner(s)
- 2.15** The King's Ball Commissioner(s)
- 2.16** The Off Campus Commissioner(s)
- 2.17** The Orientation Week Commissioner(s)
- 2.18** The Pro Shop Commissioner(s)
- 2.19** The Promo Team Commissioner(s)
- 2.20** The Athletic Facilities Coordinator(s);
- 2.21** The Treasurer;
- 2.22** The Website Commissioner(s);
- 2.23** The Concert Commissioner(s); and,
- 2.24** The Student Outreach Commissioner(s).
- 3.0** The Council will set requirements for each position as necessary on a yearly basis.
- 4.0** Applications for appointments will open no earlier than 1 March and last at least one (1) week.

ARTICLE XIX: PROTECTION OF COUNCIL

- 1.0** Limitation of Liability: No member of the Executive of the Council, nor any member of a committee shall be liable for the acts, receipts, neglects or defaults of any other member or for joining in any receipt or other act of conformity, or for any other loss, damage or misfortune whatever which will happen in the execution of the duties of his/her office, unless the same be occasioned by his/her wilful neglect or default by his/her own dishonest or fraudulent act.
- 2.0** Indemnity: Every member of the Council or member of a Committee and his/her heirs, executors and administrators, respectively, shall at all reasonable times be indemnified and saved harmless out of funds of the Council from and against:
- 2.1** All costs, charges and expenses whatsoever that such member sustains or incurs in or about any action, suit or proceeding which is brought, commenced or prosecuted against him/her for in respect to any act, deed, matter of thing whatsoever made, done or permitted by him/her in or about the execution of his/her duties office; and,
- 2.2** All other costs, charges and expenses that s/he sustains or incurs in or about in relation to the affairs of the Council except such costs, charges or expenses as are occasioned by his/her own wilful neglect or default of his/ her own dishonest or fraudulent acts.
- 3.0** Validity of Actions: No act or proceeding of member of the Executive of the Council, nor any member of a committee shall be deemed invalid or ineffective by reason of the subsequent ascertainment of any irregularity in regard to such act or proceeding or the qualifications of such members of the Executive of the Council, nor any member of a Committee.
- 4.0** Member's Reliance: No member of the Executive of the Council, nor any member of a Committee may rely on the accuracy of any statement or report prepared by the Council Accountant and shall not be responsible or held liable for any loss or damage resulting for acting upon such statement or report.

ARTICLE XX: VACANCIES

- 1.0** The office of a member will become vacant after the resignation, dismissal or demise of the member.
- 2.0** If the office of the President should become vacant, the Vice President Finance will act as the President until the vacancy is filled.
- 3.0** The vacancy of any elected position will be filled by election:
- 3.1** Nominations for the vacant position will open at the very latest four (4) weeks after the creation of the vacancy and last at least one (1) week;
- 3.2** Notwithstanding subsection 2, if the position becomes vacant after March 15, the nomination period will not open before September 15 and last at least one (1) week;
- 3.3** The campaign period will follow the nomination period, last one (1) week and will include an All Candidates' Forum, which will be set by the C.R.O., with consultation of the President for information purposes only;
- 3.4** The election will be held on two (2) consecutive days following the campaign period; and,
- 3.5** In any case, the election will be held within six (6) weeks of the opening of nominations.
- 4.0** The vacancy of any appointed position will be filled by appointment:

- 4.1 Applications for the vacant position will be opened within four (4) weeks after the creation of the vacancy and last at least one (1) week;
- 4.2 Notwithstanding subsection 2, if the position becomes vacant after 15 March, the nomination period will not open before 15 September and last at least one (1) week; and,
- 4.3 In any case, all appointments will be made within six (6) weeks of the opening of the application period.

ARTICLE XXI: NOTICES

1.0 Method of Giving Notices:

1.1 Any notices (which term in this Article XIX includes any communication or document) to be given pursuant to the Act, the letters patent, the by-laws or otherwise to a member, trustee, officer or auditor shall be sufficiently given if delivered personally, mailed by prepaid ordinary post, or electronically transmitted;

1.2 The Recording Secretary may change the address on the Council books of any member of the KUCSC or auditor in accordance with any information believed to be reliable. A notice so delivered shall be deemed to have been given when it is personally or electronically transmitted; a notice mailed shall be deemed to have been given four (4) days after deposit in a post office or public letterbox.

2.0 Computation of Time:

2.1 In computing the date when notice must be given under any provision requiring a specified number of days' notice of any meeting or other event, the date of giving the notice shall be excluded and the date of the meeting or other event shall be included.

3.0 Omissions and Errors:

3.1 The accidental omission to give any notice to any member of the KUCSC or auditor or the non- receipt of any notice by any member, trustee, officer or auditor or any error in notices not affecting the substance thereof shall not invalidate any action taken at any meeting held pursuant to such notice or otherwise founded thereon.

4.0 Waiver of Notices:

4.1 Any member, trustee, officer or auditor may waive in writing any notice required to be given.

ARTICLE XXII: ACCOUNTANT

1.0 Members of the Executive shall at each annual meeting appoint an accountant to prepare the financial statements and handle the tax return of the Council, to hold office until the next annual meeting, provided that the Executive may appoint any accountant to fill any casual vacancy.
